The terms and conditions applicable for the above committee would be as follows:

- The Chairperson, members and the special invitee shall be at the term of two years.
- The Quorum for the meeting, including the Chairperson, but excluding the special invitee, shall be three.
- In considering the grievances before it, the CDOE-SGRC shall follow principles of natural justice.
- The CDOESGRC shall send its report and recommendations, if any, to the President, MUJ, Program Coordinator, Director-CDOE with a copy thereof to the aggrieved student within 15 days of the receipt of the grievance.
- Any student aggrieved by the decision of the Centre for Distance and Online Education Student Grievance Redressal Committee may prefer an appeal to the Ombudsperson, within a period of fifteen days from the date of receipt of such decision.

UG Programmes (BBA, B.Com & BCA)	10+2 from a recognized board, or equivalent qualification as recognized by the Association of Indian Universities, in any discipline with at least 45% marks in aggregate (40% for reserved categories).	10+2 from a recognized board, or equivalent qualification as recognized by the Association of Indian Universities, in any discipline with at least 40% marks in aggregate (35% for reserved categories).
